**Draft Amendments to the Tamil Nadu Motor Transport Workers' Rules.**

No. SRO A-18/2019.—The following draft amendments to the Tamil Nadu Motor Transport Workers' Rules, 1965, which is proposed to be made in exercise of the powers conferred by sub-sections (1) and (2) of Section 40 of the Motor Transport Workers Act, 1961 (Central Act 27 of 1961), is hereby published for information of all persons likely to be affected thereby as required under sub-section (1) of Section 40 of the said Act.

2. Notice is hereby given that the following draft amendments will be taken into consideration on or after the expiry of six weeks from the date of publication of this notification in the *Tamil Nadu Government Gazette* and that any objection or suggestion which may be received from any person with respect thereto, before the expiry of the aforesaid period, will be considered by the Government of Tamil Nadu. Objection or suggestion, if any, should be addressed induplicate to the Secretary to Government, Labour and Employment Department, Fort St. George, Chennai-600 009, through the Commissioner of Labour, Chennai-600 006.

(6) For the expressions "**Inspector of Labour**", "**Inspectors of Labour**" wherever it occurs in the said Rules and Forms, the expressions "**Assistant Commissioner of Labour (Enforcement)**", "**Assistant Commissioners of Labour (Enforcement)**", shall be substituted respectively;

**Amendments to the Tamil Nadu Contract Labour (Regulation and Abolition) Rules.**

No. SRO A-19/2019.—In exercise of the powers conferred by Section 35 of the Contract Labour (Regulation and Abolition) Act, 1970 (Central Act 37 of 1970), the Governor of Tamil Nadu hereby makes the following amendments to the Tamil Nadu Contract Labour (Regulation and Abolition) Rules, 1975, the draft of the same having been previously published, as required under sub-section (1) of Section 35 of the said Act.
