Sub: Implementation of reforms under Ease of Doing Business; Action Plan 2019 - regarding.

PREAMBLE:

The Department for Promotion of Industry and Internal Trade (DPIIT) Ministry of Commerce and Industry, released the Business Reform Action Plan (BRAP) 2019 which consists of 80 recommendations for reforms on regulatory processes, policies, practices and procedures spread across 12 reform areas.

As part of Ease of Doing Business in the Karnataka State and in compliance Business Reforms Action Plan (BRAP) 2018 issued by Government of India, implementation of Action Point 42 was proposed pertaining to Labour Department which recommends to eliminate renewal of registration under the Shops and Establishment Act 1961. In this connection a review meeting with regard to the implementation of reforms under Ease of Doing Business- BRAP 2019 was convened on 25/4/2019 under the Chairmanship of Chief Secretary, Government of Karnataka.

In the proceedings read at above (1) status of implementation of Action Point 42 was reviewed and it was suggested to the department to propose for elimination of the renewal requirement under Shops and Establishment Act and consider issuing a Government Order/Executive Order in this regard so that reform can implemented well within time. Parallely, the department may propose for amendment and may follow up for amendment of rules.

In the letter read at above (2) the Labour Commissioner proposed that Government may eliminate the renewal of registration under the Karnataka Shops and Commercial Establishments Act, 1961 and the registration of establishments under the Act henceforth may be auto renewed after the submission of self Certification and payment of fees online through department portal.
