

As per notification the need to enhance productivity and efficiency in the manufacturing sector and in compliance with the directives of the department for promotion of Industry and Internal trade (DPIIT) regarding the reform and simplification of regulations and procedures related to ease of doing business and ease of living in the identified priority areas. The Andaman and Nicobar administration the daily hours of and adult worker in ay factory within the Union Territory of Andaman and Nicobar Islands is hereby revised. No adult worker shall be required or allowed to work in a factory for more than ten hours in any day.
